

The Facts—and the Myths— About Liberty Lobby & the IHR

For nearly thirty years patriots across America thought that gregarious and charming Roy Bullock, a San Francisco

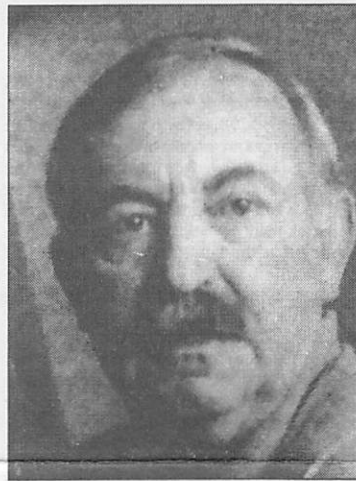

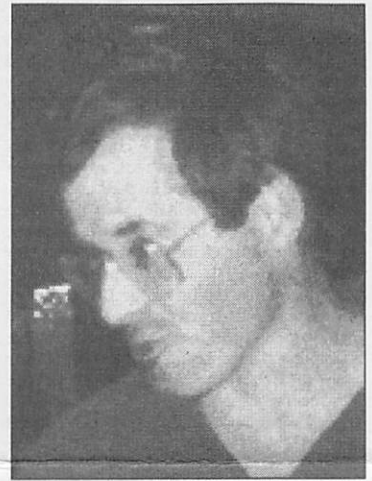
Will it take seven more years (as in the Bullock affair) before the proof about Andrew Evered Allen finally comes to light—after it's already too late?

Who is Andrew Allen? Why should LIBERTY LOBBY Board of Policy (BOP) members be concerned about his activities? These questions and more will be answered in thorough detail in this special report.

Andrew Allen is the shadowy veteran covert intelligence operative who (at the behest of his behind-the-scenes sponsors): 1) orchestrated the illegal seizure of the assets and inventory of the California-based Institute

for Historical Review; and then 2) using the resulting controversy over control of the IHR as the linchpin, instigated the March 22, 1995 SWAT-team raid on the West Coast office of LIBERTY LOBBY. The violent raid, which cost the taxpayers of bankrupt Orange County, California some \$400,000 (including the use of a helicopter) was conducted for the ostensible purpose of uncovering "loot" that Allen's henchmen claimed LIBERTY LOBBY founder Willis Carto allegedly "embezzled" from the IHR.

Allen is now financing fully seven different lawsuits involving LIBERTY LOBBY and other patriotic institutions for the precise purpose of draining their resources. He has spent upwards of \$300,000 so far in this pursuit. Allen's ultimate goal is the destruction of LIBERTY LOBBY, the backbone of the patriotic movement in America. Unless Allen is stopped, he may ultimately succeed.

Over the last ten years Allen has been ingratiating himself with grass-roots Americans in the populist and historical revisionist movement, but behind the scenes he has been working with Israel's Mossad: From running "supplies" to the lucrative Mossad-controlled drug-and-guns-smuggling networks in the Middle East to orchestrating operations against the nationalist military government of Burma (See accompanying stories).

One of Allen's tricks is to give money (probably Mossad money, no less) to sincere patriots and tell them he supports their efforts. In that way, some have been taken in

by Allen and they find it hard to believe he's not really "on their side." But intelligence agents just like Allen have a long history of stirring up dissent and confusion in the patriotic movement and in the past several years that's precisely what Allen's been doing. And many patriots are still being fooled by his slick "line."

It's impossible to say precisely whether Allen is "CIA" or "FBI" or "BATF" or "Mossad" or some combination thereof. In the strange world of intelligence (which the Mossad's mole in the CIA, the late James Angleton, called "a wilderness of mirrors") it's anyone's guess! Often-times covert operatives wear several hats and work for several different "sponsors."

Allen is, in short, a member of what former intelligence operative Col. L. Fletcher Prouty has described as "the Secret Team." That Allen, a self-described "liberal Republican," would be part and parcel of the murky world of the Secret Team is actually no surprise, considering the long-time image of the high-toned Establishment oriented nature of the world of the so-called "old boy" network of the CIA and its forerunner, the OSS whose acronym, its critics said, stood for "Oh, So Social."

It is vital that Allen be thoroughly exposed so that his efforts may be stopped dead. The purpose of this special issue of *Liberty Letter* is to explain, in thorough detail, once and for all, the facts about Allen's role in this ongoing tragedy and clear up the myths and the confusion that his activities have created. ♦



On November 19, 1995, *Parade* magazine hailed "The New CIA" in an intriguing cover story (shown here). ABOUT THIS SPECIAL REPORT...

On November 26, 1996 Judge Runston D. Maino of the Superior Court of California levied a judgment of \$2,650,000 on Liberty Lobby and \$6,430,000 on its treasurer, Willis A. Carto. The judgment is the result of a suit filed in July, 1994 against Carto, Liberty Lobby and other defendants for alleged conversion of assets (see above). In 1985, the late Jean Farrel had bequeathed the assets in controversy to Carto's care for disposition to populist causes as Carto saw fit. However, Maino decided that Carto had no right to dispose of the funds in the fashion he did, even though Carto was operating under a written agreement with the directors of the parent company of the Institute for Historical Review (IHR) that left the matter to Carto's discretion. Maino ignored this contract as if it did not exist even though the contract was sanctified by a formal vote by the board of directors four days after it was agreed upon. Maino's judgment followed on the heels of a conspiracy against the IHR and an armed *coup d'etat* in 1993 by four employees who illegally elected themselves to the board of directors after forcing the legitimate board to resign. The four employees, in league with other conspirators, then began filing a series of lawsuits against Carto, Liberty Lobby and other defendants.

This special report explains, in thorough detail, the circumstances leading up to the IHR *coup* and the events that followed, culminating in Judge Maino's decision. The report itself is an exact photographic reproduction of an issue of Liberty Lobby's newsletter, *Liberty Letter*, sent to the populist Institution's Board of Policy members as a "wrap" accompanying the March 4, 1996 issue of The SPOTLIGHT. Although the masthead and mailing date printed on the original have been deleted to make room for this special introduction, *not a single word in the report has been changed*. Liberty Lobby's position on this controversy has been consistent.

Many Factors Manipulated

The calculated destruction of the California-based Institute for Historical Review (IHR) and the resulting intrigue that enmeshed LIBERTY LOBBY was a high-level intelligence operation with far-reaching connections to not only the CIA but also Israel's intelligence agency, the Mossad. The conspiracy was multi-level in nature and took advantage of some factors that evolved on their own.

Although Andrew Allen was the prime operational mover behind the IHR takeover, there were other elements at work. Here, for the first time, is a description of the conspiracy that led up to the IHR take-over which explains how previously loyal and hard-working revisionists inside the IHR were manipulated into playing critical roles in their own destruction, not to mention the destruction of the IHR.

The explanation as to how IHR Journal Editor Mark Weber (who had otherwise appeared to be a loyal revisionist) was roped into the conspiracy is basic and readily discerned. Although a competent writer and researcher, Weber's skills as an editor were lacking and IHR founder Willis Carto was actively recruiting someone to take Weber's post as editor. Weber knew his demotion was imminent and he was determined to preserve his sinecure at any cost. Weber's employment with the IHR was the only paying job he ever had in his chosen field—in fact, the only decent job he had ever had in his 45 years. He believed his reputation as a "revisionist leader" was on the line and was thus easily manipulated.

Power and greed were also factors: Weber—who until recently sported a Hitler moustache and hair style—revealed to confidants that he had the grandiose dream of using Jean Farrel's money to purchase control of smaller independent populist, nationalist and revisionist publications and organizations

around the United States (if not the world itself) and establishing himself, in effect, as "grand pooh-bah" of the entire movement.

• Attorney William Hulsy, who had been handling a variety of legal matters for the IHR, was angry that Willis Carto had taken one IHR legal matter out of his hands—a financial setback for Hulsy. By conspiring with the disloyal employees Hulsy believed that he could, as one person told him, "walk away a very rich man" by helping grab control of the money that the late Jean Edison Farrel had bequeathed to Willis Carto's care (See accompanying story). Ultimately, following what Hulsy himself described as the "terribly disloyal . . . coup d'etat" at the IHR by the manipulated employees, Hulsy pocketed some \$200,000 in "legal fees" that he was paid by the staff members out of IHR funds for his participation in that coup.

• IHR staffer Theodore O'Keefe, although widely respected by his peers at that time, had a long history of emotional instability and was ripe for exploitation by Andrew Allen. Among other things, O'Keefe felt he was underpaid, even though he was earning far more money at the IHR than he ever earned in his erratic work career and finally had a job ideal for his training. The naive O'Keefe relied heavily upon Andrew Allen's "legal advice" (believing Allen to be a sincere revisionist) and worked closely with attorney Hulsy in the months leading up to the IHR coup, not knowing the full depth and breadth of the multi-level conspiracy in which he had been entrapped. Now, O'Keefe is in the care of his parents (having left the IHR) and reportedly suffered a mental breakdown in the wake of the IHR mess that he helped cause.

• The role of IHR operations director Tom Marcellus in the conspiracy points to the mysterious role his religious cult played in the IHR takeover. This cult, which will remain

nameless, has all the earmarks of a CIA-Mossad mind control and intelligence operation. The cult's role is a factor in the IHR affair that has confused many people. Why would the cult be interested in destroying the IHR? The answer is that the cult had two interests in so doing:

First of all, on October 1, 1993—the very day that Tom Marcellus, in league with Andrew Allen, "terminated" Willis Carto's relationship with the IHR—the IRS granted the cult a tax exemption (which the cult had sought for 30 years) worth millions of dollars to its wide-ranging, multi-faceted international operations—a worldwide corporate empire with its own intelligence network. This tax exemption could never have been granted unless the high-level influence of the Anti-Defamation League of B'nai B'rith (ADL) had not been brought to bear.

The evidence is that a secret agreement was reached between the ADL and the cult's highly-secretive and dictatorial leader, a shadowy figure whose critics call him "The Wizard of Oz": in return for the "Wizard" deploying Marcellus in the IHR conspiracy (manipulating events from within), the ADL "arranged" for the cult's tax exemption.

There was an additional critical factor also at play. At the very time that the IHR coup was set in motion, the cult had become engaged in a vituperous public relations and political struggle with the government of Germany over that government's wide-reaching campaign to stamp out the expansion of the cult's operations in Germany.

According to a high-ranking former diplomat who has watched the cult closely, the cult cut yet another secret deal, this time with the German government: in return for its role in subverting the IHR from within and thereby undermining the IHR (which had been a thorn in the side of the German government), the cult would receive more lenient treatment by the Germans.

Since the IHR coup, the cult has crowed in its internal publications about the "victories" that they have achieved in the German legal system, although they continue to bemoan widespread alleged "prejudice" in Germany.

The evisceration of the IHR by the Mossad's Andrew Allen, in league with this international cult, came at precisely the time that German government raids on the homes and offices of German revisionists and populists were taking place (similar indeed to the raid, in America, on the West Coast office of LIBERTY LOBBY).

In fact, international media reports at the

time linked LIBERTY LOBBY and the IHR to the very German victims of the government raids (however incorrect those media reports were), pointing out that the IHR was a primary worldwide source of revisionist literature.

So there are at least two known reasons why the cult became involved in the IHR affair.

It should be added that Tom Marcellus, a veteran IHR staff member, had installed two other cultists in key positions at the IHR: newly-hired assistant editor Greg Raven (a long-time cultist who kept his affiliation secret) and administrative assistant Michelle Matteau, a former Christian whom Marcellus converted to his cult. Marcellus was well-placed and quite capable of manipulating events around him, playing upon a wide variety of motives that came into play as the IHR takeover scenario unfolded.

Through another cultist, one Matthew Peter Balic, who was close to prominent revisionist Frederick "Fritz" Berg, a member of the IHR's board of advisors (and subsequently appointed by Andrew Allen to the bogus IHR corporate board of directors) Marcellus was further able to manipulate the events leading up to the IHR coup.

Although the conspiracy had been set in motion early in 1993, *Liberty Letter* has learned that months before Marcellus, at Allen's direction, surfaced the coup on October 1, 1993, Balic spoke openly about the impending coup as though it were a *fait accompli*. Balic is believed to be a full-time covert operative for the cult's famed international intelligence and dirty-tricks network that rivals even that of the ADL but which is now, obviously, working in tandem with the Mossad.

(As an item of peculiar note: One well-known hero of revisionists who is very familiar with Balic and spent much time in his company over a period of several years was intrigued to learn of Balic's cult connection because he had become convinced on his own that Balic was a Mossad operative. This, of course, is also a distinct possibility, inasmuch as covert operatives frequently wear several hats, working for a number of intelligence organizations simultaneously.)

• There is yet another intriguing connection that explains how the cult controlling Marcellus and the ADL found common cause in the IHR penetration operation. Lawrence Heller, the high-powered Los Angeles trial lawyer, who was chief counsel for self-promoting Holocaust survivor Mel Mermel-

CIA, MOSSAD, CULTS . . .

In reference to the peculiar role of a bizarre cult leader—the so-called "Wizard of Oz"—in the IHR affair, it is worth pointing out that there are those who believe that this cult is an outgrowth (or perhaps even a creation) of the CIA's infamous mind-control operations launched after World War II. These mind control experiments (which have been widely publicized) were under the supervision of James J. Angleton, the Israeli loyalist who headed the Mossad liaison desk at the CIA.

Here's how the CIA's mind control operations (utilizing cult-like front groups) work: Utilizing its long-honed mind-control techniques researched and tested at taxpayer expense, the CIA sets up artificial entities with a wide variety of philosophical, social, religious and political outlooks. The CIA controls these groups—popularly known as "cults"—for the benefit of the plutocrats who control the CIA. Cult members do not know, of course, that they are now part of a highly-sophisticated intelligence-based mind-control operations. This is documented by numerous personal confessions and books.

Cult members are indoctrinated by their cult leaders through brainwashing techniques derived from long-standing CIA and Mossad study. The cult members become completely subservient zombies, willing to do whatever their controllers order. The cult members are from all walks of life and some reach high positions of influence within the companies and organizations in which they work in their day-to-day life. However, their loyalty is to their cult because of the "brainwashing" process to which they are constantly subjected. Sometimes the cult members are open about their cult membership. Other times, for strategic reasons, they are instructed not to reveal their cult affiliation. Whether the cult members are employed by political groups, research institutes, banks, insurance companies, government agencies, or even a very well-known department store chain, they will always be available for deployment when their higher-ups in the cult (operating at the behest of the CIA and the Mossad) make the decision to carry out some particular intelligence operation—such as taking over or wrecking the targeted organization, for example, the IHR, from within.

ALLEN'S FIRST STOOGES . . .

After an embittered former Institute for Historical Review staff member, David McCalden, was fired from the IHR, Andrew Allen began financing his activities. During the same period McCalden was also collaborating closely with another San Francisco "revisionist," Roy Bullock, later exposed as an ADL spy. Under the tutelage of the two operatives, McCalden launched a well-financed propaganda campaign against the IHR that had all the earmarks of a high-level intelligence operation.

In fact, according to information released publicly as long ago as November 7, 1984 by respected veteran revisionist historian H. Keith Thompson, McCalden was indeed being fed intelligence by a CIA middleman. In Thompson's judgment, however, it was "more likely" that McCalden received "some sort of minor compensation from the Mossad . . . since he perform[ed] a considerable service for them, causing divisiveness and mistrust among individuals and groups threatening their interests."

In light of all that is known about Allen's activities, it is interesting then that Ted O'Keefe and Mark Weber, supposedly loyal revisionists, allowed themselves to be manipulated by Allen as they did.

stein in the last incarnation of Mermelstein's ten-year-long ADL-backed campaign to destroy the IHR, also had close, high-level ties to the cult. In fact, prior to taking on the Mermelstein case Heller had defended the cult (unsuccessfully, it so happens) in a multi-million dollar suit brought against it by a reformed cultist.

In the wake of his bitterly-felt defeat by attorney Mark Lane (representing the IHR and Liberty Lobby) in the Mermelstein case, Heller appears to have been the central figure in arranging the strategic alliance between the cult's leader and the ADL and its allies in the intelligence community.

This then explains how the leaders of the cult were brought into the midst of the IHR conspiracy and thus answers the many

questions raised by many low-level members as to how and why the cult (seemingly inexplicably) became enmeshed in the IHR-LIBERTY LOBBY affair.

• There is another factor worth examining: the role of prominent French revisionist Robert Faurisson in supporting the IHR conspirators in their coup. A devoted advocate of multi-culturalism whose daughter is married to a Third World immigrant, Faurisson was angry that the IHR's legitimate board of directors had determined that the IHR would begin focusing on historical aspects of the growing problem of multi-culturalism and feared that the primary English-language market for promotion of his writings would somehow be curtailed. Thus, Faurisson was easily manipulated by IHR employee Weber, who treacherously enlisted

Faurisson's support for the conspiracy. Faurisson himself, in turn, used his own influence with other prominent revisionists to turn them against Carto.

It was in the wake of the aforementioned defeat of Mel Mermelstein by the IHR and LIBERTY LOBBY that the ADL itself became involved in its now-infamous spy scandal in San Francisco that has resulted in several legal actions against it.

ADL minion Roy Edward Bullock himself admitted under oath that it was LIBERTY LOBBY's exposure of him as a ADL undercover operative that had resulted in the subsequent FBI-San Francisco Police Department investigation of him that revealed the ADL's long known (but never before publicly revealed) illicit spying operations.

LIBERTY LOBBY and the IHR were preparing a

joint legal action against the ADL. Of course, the ADL was doubtless being kept informed by spy Marcellus. The ADL decided to strike first, and its Mossad sponsors did so—subverting the IHR from within. As circumstances now demonstrate, the IHR was unfortunately a vulnerable target.

On October 15, 1993, after Andrew Allen (working with his patsies on the IHR staff) had already set up a bogus board of directors for the IHR's parent company, the Legion for the Survival of Freedom, the employees (assisted by Hulsy) staged the actual armed seizure on October 15, 1993 of the IHR's office and warehouse in Costa Mesa, holding Willis Carto and his wife Elisabeth at gunpoint after having assaulted both, leaving Mr. Carto bloodied and his wife bruised, she

'EMBEZZLED' FUNDS?

The raid on Liberty Lobby's West Coast office (located in the home of Liberty Lobby founder Willis A. Carto) was spurred by a criminal complaint filed against Willis Carto at Andrew Allen's direction by IHR employees Mark Weber and Tom Marcellus. The two falsely alleged that Carto had "embezzled" money from the Legion for the Survival of Freedom (LSF), the corporate parent of the IHR. (For more on the LSF, see the accompanying story.) The funds allegedly "embezzled" by Carto were funds left to Carto's care for disposition as he deemed best by the late Jean Edison Farrel, a grand-niece of the late American populist inventor, Thomas Alva Edison.

Miss Farrel, along with other members of her family, including the late Governor Charles Edison of New Jersey (son of the inventor) were long-time supporters of Liberty Lobby, dating back as early as the founding of the institution by Willis Carto in 1955. (Governor Edison himself was one of the founding Liberty Lobby Board of Policy members, even prior to the time that board membership was opened to all Americans of legal age who swore their loyalty to the U.S. Constitution.) Through their association with Liberty Lobby, the Edison family members became friends with Willis Carto and his wife, Elisabeth, and followed the work of Liberty Lobby with interest.

Shortly before her death Miss Farrel approached Willis Carto and indicated her interest in bequeathing her assets to his care. At that time the proper legal arrangements were made to ensure that the overwhelming bulk of her estate would pass to Carto's control upon her demise. Upon Miss Farrel's death in 1985 there was an unexpected development.

In addition to the arrangements that she had made regarding the disposition of her assets to Mr. Carto, Miss Farrel had also executed a handwritten will bequeathing her personal effects at her home in Switzerland (as well as the meager contents of a single safe deposit box in Switzerland) to a trusted neighbor with the verbal understanding that the neighbor would assist Mr. Carto in securing the estate.

Unknown to Miss Farrel, the neighbor, a native of South Africa was a committed Zionist, holding views totally contrary to those of the Edison family. After Miss Farrel's death, the neighbor promptly laid claim to the entirety of the Farrel estate, including the funds bequeathed to Willis Carto's care, using the handwritten will as the basis for the claim.

Needless to say, an ensuing and highly expensive international legal battle erupted and—*not surprisingly under the circumstances*—the neighbor received critical backing in her effort from the ADL and other high-level forces that wanted to prevent Carto from gaining control of the estate.

Indicative of the ADL's immense concern with the affair is the fact that one of the attorneys deployed by the ADL was none other than Howard Squadron, one of the most powerful Zionist legal "fixers" operating in the world today. LIBERTY LOBBY has learned, additionally, that during two trips that Carto made to Switzerland to settle the estate, he was under close surveillance by the Mossad. LIBERTY LOBBY got this information directly from a friendly source right in our own State Department.

At the time of Miss Farrel's death, red lights went off in the offices of the ADL and in the offices of its foreign principal, the Israeli Mossad. They promptly provided tactical, financial and intelligence support to those who were involved in the effort to thwart Mr. Carto from gaining access to the Farrel estate.

Neither the IHR nor the LSF had the financial resources available to wage the litigation necessary to ensure Mr. Carto's rightful claim on the Farrel legacy. The courtroom contest dragged on for fully five years. Yet, Carto arranged for the financing that made the effort possible. He secured a number of substantial loans, including in at least one instance signing a note putting himself personally responsible for repayment—whether he secured the Farrel money or not. All told, Carto was forced to secure the services of some ten different attorneys, in the United States and Switzerland and in a number of other foreign countries where Miss Farrel's assets were located. (Hardly a penny—if any—of the resources for the litigation came from the IHR or the LSF itself.)

(Carto has put it bluntly: "Neither Tom Marcellus, nor Mark Weber nor Ted O'Keefe—and certainly not Greg Raven—had anything whatsoever to do with raising a single penny toward securing the Farrel legacy. Not a one of them ever lifted a hand. All they did was benefit from it.")

Another factor is critical to consider: Miss Farrel's death came in 1985, not long after the

devastating destruction of the IHR offices on July 4, 1984. The terrorist bombing and decimation of the IHR is another story. But suffice it to say that at the time of Miss Farrel's death, there was virtually nothing left of the IHR. Its office had been totally destroyed; its book inventory lost forever and, perhaps most importantly, there was not enough money coming in to pay the IHR's outstanding debts.

At this point Carto wasn't even certain that the IHR would be able to survive. However, thanks to the generosity of IHR supporters around the world, Carto was able to get the IHR back on its feet and operating—much, of course, to the dismay of the ADL. And all of this was taking place during the same time period that Carto was working to secure the Farrel estate.

Finally, with Carto acting for himself and as an agent for the LSF, a settlement was reached in July of 1990. Although—unfortunately—fully 55% of the Farrel estate finally went to the ADL-sponsored neighbor (despite her faulty and suspicious claim), the balance, several million dollars, was entrusted to Mr. Carto. This was (obviously) far less than the \$40 million that the lying propagandists at the ADL told the worldwide media was the amount that Mr. Carto received.

Now this is additionally important to note: although Mossad-linked operative Andrew Allen and his patsies have claimed that the Farrel legacy was intended exclusively for the IHR, Miss Farrel's primary interest was not even historical revisionism. Her major interest was the tax protest movement. She was a tax protestor. That's precisely why she had left the United States and taken up residence in Switzerland. Miss Farrel supported Liberty Lobby and The SPOTLIGHT for their fight for Constitutional taxation first and foremost.

Now again, contrary to what Andrew Allen has claimed, Mr. Carto actually made available some \$750,000 from the Farrel estate directly to the IHR. It was with this large funding that Carto made available that the IHR was able to rebuild its book inventory (lost in the 1984 fire) that, until the IHR coup, brought a great deal of revenue to the IHR and made possible the work of the IHR, not to mention paying the salaries of the people who ultimately did so much to wreck the IHR from within.

Allen and his henchman have been selling off this book inventory at fire sale prices in order to continue paying Mark Weber and Greg Raven, the remaining IHR staff members, their salaries—even as they are alleging that Carto not only "embezzled" money but that he never made any of the Farrel estate available to the IHR.

Another important factor must be noted: at the time of the settlement of the Farrel estate, both the IHR and Liberty Lobby were together facing a potentially-devastating ADL-backed eleven million dollar nuisance suit filed against them by Holocaust survivor Mel Mermelstein, the second such suit by Mermelstein during a ten-year period.

The ADL widely publicized the fact that a substantial fortune had been entrusted to Carto's care by Miss Farrel, and Mermelstein's lawyers bragged publicly—and actually told the court—that they intended to grab control of the Farrel legacy. This was part of their scheme to bankrupt both LIBERTY LOBBY and the IHR.

Although the IHR and LIBERTY LOBBY were both founded by Willis Carto, the two institutions had always operated entirely independently of one another (See accompanying story.) Yet, Mermelstein had dragged LIBERTY LOBBY into this lawsuit which arose strictly from a long-standing fight between the Holocaust survivor and the IHR. LIBERTY LOBBY had nothing to do with Mermelstein in any way.

In an effort to protect LIBERTY LOBBY and the IHR from Mermelstein and his ADL backers and at the advice of attorneys (including then-IHR attorney William Hulsy), Carto structured the LSF assets and the funds received from the Farrel estate in such a way as to make them legally judgment proof. Fortunately, through the skillful legal work of attorney Mark Lane, Mermelstein's lawsuit was eviscerated on September 19, 1991 and the IHR and LIBERTY LOBBY were able to continue with their independent ventures, safe from any possible crippling legal judgment.

Even as this is written Andrew Allen and his patsies continue to trumpet the claim that Willis Carto "embezzled" untold millions—Weber once claimed it was as much as "80 million dollars"—and, unfortunately, many who have not been privy to the facts as reported in The SPOTLIGHT (and again in this special report in *Liberty Letter*) believe the lie. This report, however, should set the record straight. ♦

Mark Weber's Lies Exposed

There is a great deal of confusion on the part of many patriots about the relationship between LIBERTY LOBBY, the Washington-based populist Institution, and the California-based Institute for Historical Review, which have, from the beginning, been entirely separate institutions. Although self-promoting "Holocaust survivor" Mel Mermelstein named both as defendants in his meritless legal actions, LIBERTY LOBBY and the IHR were always two totally different Institutions with entirely different missions.

For those who are interested, here is a brief overview of the history of the two. These facts help explain the background to the series of events that led to the destruction of the IHR and the ongoing attempt to destroy LIBERTY LOBBY being orchestrated by the enigmatic Andrew E. Allen.

LIBERTY LOBBY was founded by Willis Carto in 1955 as a grass-roots citizens' lobby. Its continuing purpose since that time has been to not only provide patriots an action-oriented lobbying organization on Capitol Hill in Washington but also a source of information and a clearing house for grass-roots patriotic efforts around the country, both complementing and uniting their efforts.

The Institute for Historical Review, along with the Noontide Press, operated under the auspices of the Legion for the Survival of Freedom (LSF). Contrary to Andrew Allen and his benchman in the IHR conspiracy, Mark Weber, the LSF's mission was never solely limited to the purposes of promoting the work of the IHR. In fact, the IHR was only a subdivision of the LSF, established nearly 30 years after the LSF was incorporated.

The LSF was a Texas corporation first established by the late Jason Matthews in 1952. By 1966, however, the LSF was going into bankruptcy, unable to continue publishing its popular *American Mercury* magazine. At that time Willis Carto, already the founder and treasurer of LIBERTY LOBBY, stepped in, paid off the debts of the LSF, assumed actual control and management of the corporation and made possible the continued publication of the *Mercury* until the mid-1970's. Carto also merged the previously-operating Noontide Press into the LSF as one of its subdivisions. He also brought the *Washington Observer* newsletter (until then being published by LIBERTY LOBBY) under the legion's umbrella. It was not until 1979 that Carto even established the IHR as an LSF subdivision.

Serving continuously as a member and officer of the LSF board of directors—until the 1993 IHR coup—was Mrs. LaVonne D. Furr who was coerced into resigning her post by lies, threats and intimidation by Andrew Allen's patsies on the IHR staff who were being manipulated by Allen into participating in the conspiracy to wreck the IHR.

The staffers told Mrs. Furr that she and her husband Lewis, president of LSF—faced legal trouble—and possible prosecution—for what the staffers claimed were illegal activities by Mr. Carto in the management of the LSF's assets, although this claim had no basis in fact. Additionally, attorney William Hulsy, while under ethical obligation to the legitimate board of directors—including the Furr's—was hired by Andrew Allen to give the Furr's false legal advice which led to their resignations.

Although Carto himself actually only served as an officer on the LSF board for a short period in the 1960's, he was at all times a member of the corporation—in legal parlance, a "substitute incorporator." In

other words, under the by-laws (officially recognized by the state of Texas), Mr. Carto with Mrs. Furr had the ultimate, uncontrollable right and responsibility to appoint the members of board of directors.

Under no circumstances, then, could Carto be "removed" or terminated as the IHR employee/conspirators attempted to do in their illicit, backstage coup d'etat on October 1, 1993 when Allen's henchmen advised both Willis Carto and his wife Elisabeth, who functioned as the IHR's unpaid comptroller and disbursements officer, that their association with the IHR had been unilaterally terminated by the new (and bogus) "board of directors" secretly established under Andrew

Allen's direction on September 24, 1993.

Although Carto never served as a paid employee of the IHR itself (but did serve, at times, as a designated legal agent for the institute and its parent company) it was well-known—most widely publicized by even the ADL itself—that Carto was the founder of, chief fund-raiser for, and guiding force behind the IHR and the actual chief of operations for the LSF. Despite all this, the IHR conspirators are now claiming that the IHR founder's relationship with the IHR was—in Mark Weber's outrageous and lying words—"peripheral at best," and that he and his wife, Elisabeth, were only insignificant "volunteers" who were somehow attempting to exert

authority over the LSF/IHR in an illegal, covert fashion in violation of the corporate by-laws.

After the legitimate directors of the IHR, with Carto's support, brought suit challenging the illicit take-over over of the LSF by the paid staff members, a California state court issued an ambiguous ruling that completely failed to resolve the matter. Now, however, a Texas court (which has far more formal actual legal jurisdiction over the matter) has ruled that a suit filed on Carto's behalf by the legitimate LSF board of directors should go forward. Ironically, the Texas ruling was being handed down at the very moment as the ransacking of LIBERTY LOBBY's West Coast office was taking place. ♦

Allen's CIA, Mossad Ties Outlined

On September 10, 1995 a special report (pictured here) was released. The report outlined the multi-faceted links between Andrew E. Allen, prime mover in the campaign to destroy LIBERTY LOBBY, and both the CIA and its collaborators in Israel's Mossad. Although Allen postures publicly as a "revisionist" and as a lawyer and real estate entrepreneur, the San Francisco-based operative admitted under oath on October 7, 1994 that for some ten years he was involved in "running" (and then amended his words to say "taking") what he called "supplies" to the Mujahideen rebels in the Middle East. What Allen did not say was that this was part of the "the second largest covert operation" in the CIA's history, according to former Mossad operative Victor Ostrovsky, or that this

CIA-financed operation in which Allen was actively engaged was also under the direct supervision of the Mossad. There's much more to the story about Allen's ties to this international intrigue that has yet to be told, but suffice it to say, Allen's long-time role in this Mossad operation proves, beyond any question, that there's a lot more to this "liberal Republican" from San Francisco than meets the eye. But Allen's international operations involving the CIA and the Mossad do not end with the Middle East, by any means.

Perhaps even more intriguing is Allen's involvement in the joint CIA-Mossad sponsored covert (and overt) operations designed to bring down the populist military regime that rules in Myanmar (formerly known as Burma).

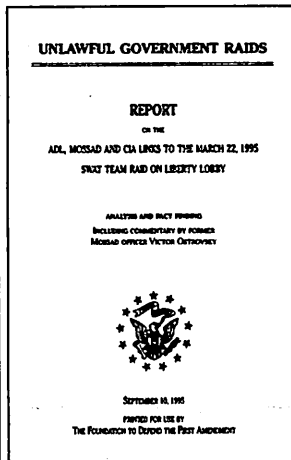
Allen admitted under oath on October 7, 1994 that he was "on the board of directors" of an organization called the Burma Foundation, the purpose of which he said was to "promote democracy in Burma." What Allen did not say was that he was also the founder of this little-known foundation which bears the precise profile of the myriad front groups established by the CIA and the Mossad for their operations.

Why would Allen and his sponsors in the CIA and the Mossad be interested in Burma? The fact is that the nationalist regime in Burma is struggling to withstand the onslaught of the international financial community and has rejected CIA and Mossad influence in the nation's affairs. This is of particular concern to the Mossad since the previous government of Burma had been a pliable tool of Israel until a nationalist regime came to power in Burma. As a consequence, the new Myanmar government has been targeted for removal by the Mossad. Joining Allen in targeting Myanmar is the Soros Foundation of Zionist billionaire George Soros and the National Endowment for Democracy headed by former ADL official Carl Gershman.

The global activities of Andrew E. Allen are not those of the average American. They do reflect, however, those of a long-time veteran high-level covert intelligence operative.

having been battered upon the face and neck.

In the aftermath, as part of their public relations offensive to explain their disloyal and criminal actions, Allen and his patsies began making the claim that Willis Carto had misappropriated and "embezzled" funds that they claimed were earmarked for the IHR, referring specifically to those funds that had been left to Carto's care by Jean Farrel.

Finally, in February, 1995, as their legal battle began to collapse and as their financial support began to dwindle with the truth about their conspiracy gaining wide circulation—leaving the IHR on the verge of bankruptcy—Weber and Marcellus (at Allen's prodding) actually made a formal complaint to the Costa Mesa, California Police Department claiming that Carto and an associate, Henry

Fischer, who had helped Carto secure the Farrel estate, had "embezzled" the funds.

Earlier, Allen arranged with Marcellus to make a similar complaint to the California state attorney general, but the attorney general saw that the complaint was spurious and took no action. Then Allen filed a complaint with the attorney general of Texas (where the IHR's parent company is incorporated) and the Texas authorities likewise declined to take action.

However, a friend of attorney William Hulsy's, Costa Mesa Police Investigator Larry Rooker who mysteriously popped up in Costa Mesa in 1994 (after having worked for the Los Angeles Police for 29 years) showed unusual interest in the complaint. Acting on the prodding of Weber and Marcellus, Rooker organized the multi-

jurisdictional SWAT team that raided the Carto home, the West Coast office of LIBERTY LOBBY. Heading up the San Diego contingent of officers was San Diego County Deputy Sheriff Tim Carroll, an admitted long-time informant for the ADL.

Rooker has actually said—on more than one occasion—that if Carto paid off Allen and his coconspirators that he (Rooker) would be willing to forget about the alleged crimes. In other words, Rooker is saying that while he "thinks" Carto committed a crime, he is ready to "forget it" if Carto pays off the IHR gang. The legal term for Rooker's offer is extortion.

This, in all of its complex essence, is how the IHR coup d'etat came about. It is a textbook case of how a once-vibrant and enormously influential patriotic institution can be destroyed. ♦
